I hereby certify that I am engaged in the business of conducting a timber harvesting operation; that my annual aggregate stumpage income for sawlogs, pulpwood, props, firewood, posts, rails, etc., will not exceed \$15,528 during the \_\_\_\_\_ calendar year; and that I therefore am eligible for an exemption from operator licensing and logger certification. I certify that I will use the Best Management Practices, prescribed in the "West Virginia Silvicultural Best Management Practices for Controlling Soil Erosion and Sedimentation from Logging Operations" (2009 Revision), to control any soil erosion that may come from log landings, skid or haul roads constructed or utilized for the harvesting operation, and that each operation will be reported on the official timber harvesting notification form (WVDOF-LSC-F14).

I understand that any time my annual aggregate stumpage income from timber harvesting exceeds \$15,528, I will need to get a timbering license and become a certified logger.
